Data Storage

Data Security

Cookies

Cookies are small text files stored on your computer that are used to collect information about your device and information about your user experience. This information is used to record the number of visits made and compile statistical information about the activity of the website.

Advertising cookies: are those that allow the most efficient management of advertising spaces based on criteria such as the edited content or the frequency at which the ads are displayed.

Behavioral advertising cookies: these are those that allow the management of advertising spaces as efficiently as possible. These cookies store information about user behavior, obtained through continuous observation of your browsing habits, allowing you to develop a specific profile to display advertisements based on this.
